(Pursuant to Chapter 607 and 621, Florida Status)

The undersigned persons have associated themselves for the purpose of forming a corporation under the laws of Florida and adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is: RAMONDS WHOLESALES MERCHANDISE, INC. The period of duration shall be perpetual.
