FIFTH: The name and address of the person who is to serve as the initial director is: Richard B. Silver, 3820 State Street, Santa Barbara, California 93105.

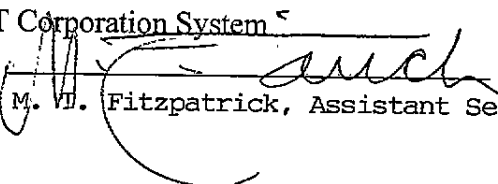
