ARTICLES OF INCORPORATION
OF
R.G. KANE, MD, P.A.

ARTICLE I - NAME

The name of this corporation is R.G. KANE, MD, P.A.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

The purpose of the Professional Association is to conduct the business of a Medical Practicing Physician in the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1000 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The number of directors may be either increased from time to time by the bylaws; however, there shall never be less than one Director nor more than five. 
