The undersigned incorporators hereby form a corporation under Chapter 607 of the Laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

P & D DANIEL ENTERPRISE, INC.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage in the leasing and rental of apartments and other investments.

ARTICLE III. CAPITAL STOCK
