THE UNDERSIGNED SUBSCRIBER to these articles of Incorporation a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is:

NOTHING FOR SOMETHING INC.

ARTICLE II

NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

- (a) To engage in every aspect and phase of sales and marketing.
- (b) To design, manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose off and to invest in, trade in, trade in and with, goods, wares, merchandise, real and personal property, and services, of every class, kind, and description; except that it is not to conduct a banking, safe deposit, trust, insurance, surety express, railroad, canal telegraph, telephone or cemetery company, a building and loan association, fraternal benefit society, state fair or exposition.
- (c) To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease, or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses, in the State Florida and in all other states and countries.
- (d) To contract debts and borrow moneys, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness, and execute such mortgages, transfers or corporate indebtedness as required.

(e) To purchase the corporate assets of any other corporation and engage in the same or other character of business.

### ARTICLE III

#### CAPITAL STOCK

The maximum number of shares that this corporation is authorized to have outstanding at any one time is THREE HUNDRED (300) Shares of Common Stock having a nominal value or par value of (\$1.00) per share

### ARTICLE IV

#### INITIAL CAPITAL

The amount of capital with which this corporation will begin business is: more than THREE HUNDRED DOLLARS (\$300.00)

### ARTICLE V

#### TERM OF EXISTENCE

This corporation is to exist perpetually.

### ARTICLE VI

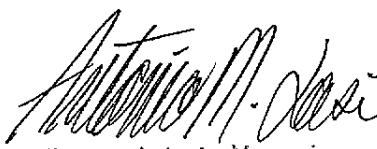

stockholders sign a written agreement manifesting their intention that a certain amendment of these Articles of Incorporation is made.
