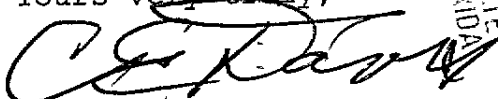

ARTICLE I. NAME

The name of this corporation is THUNDER DEVELOPMENT, INC.

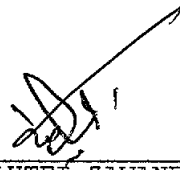
ARTICLE VIII. BY-LAWS
