ARTICLES OF INCORPORATION

OF

<u> ARTICLE I - NAME</u>

The name of the corporation is Coastal Crete, Inc., 1587 Elmhurst Circle SE, Palm Bay, Florida 32909 (Principal Office of Registered Agent).

ARTICLE II - DURATION

ARTICLE VIII - INITIAL BOARD OF DIRECTORS


