The name of the corporation is JPI HOLDINGS, INC.

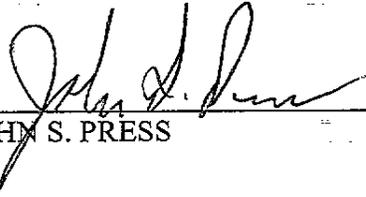

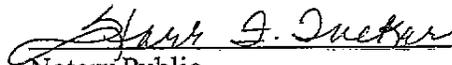

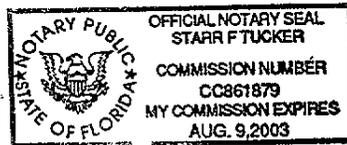
