Dear Sir or Madam:

I am writing this letter in order to reinstate Low Vision Works, Inc. Enclosed is my completed Uniform Business Report along with a check in the amount of \$150.00. I understand that the normal reinstatement fee is \$750.00. I am, however, requesting that the penalty be waived based upon the circumstances outlined below.

Initially, I never received a notice of the required Annual Report. While I have been informed that the Division of Corporations has not received the report back in the mail, I cannot explain why I did not receive it. The only explanation I can think of is that it was not properly forwarded to the new business address.

In addition to the foregoing there were a number of events occurring in my life this spring which diverted my attention from the business in general, and checking on the corporation status in particular. I am the owner and sole employee of the corporation. In the spring I was going through a very difficult pregnancy. In April 2002 I was placed on bed rest. At that time, obviously, the corporation ceased conducting any business. I remained on bed rest until I gave birth prematurely on June 11, 2002. From that time until just recently I have been taking care of my baby. My business has been closed during that time.

When I was ready to get back to work last week I started thinking about the corporation and looked to find out that I, apparently, had not filed the Annual Report. Since I did not have the original notice from the state I had to determine how to download the Uniform Business Report from the Internet to attach hereto.

I hope that the foregoing adequately explains the circumstances of the failure to timely file the Uniform Business Report and that it is sufficient reason to allow you to waive the reinstatement penalty.
