Dear Mr Dunlop

I attach the 2003 and 2004 UBR (I was told a copy of the 2003 UBR would be adequate for the 2004 return) for Computer Rookies, together with a check for \$150 to cover the 2004 UBR.

As you will see from your records there is an outstanding late fee for the 2003 UBR. However, I hope that you will be able to waive these fees for us for the following reasons:

I submitted the UBR twice in 2003, each time with an accompanying letter (attached) to explain why the UBR was submitted late. On both occasions I spoke on the phone to members of your division prior to sending the letters, to confirm that I could dispute the late fees. On both occasions I received no reply to these letters, but did receive more demands for even further increased late fees.

As I explained in those letters, we filed the UBR late, but only 2 weeks after receiving it, due to a mix-up with our registrar following my business' change of address from Fort Lauderdale to Miami. I hope you will agree that this was an understandable administrative error on the part of the registrar and that we should not be penalized. \$750 is certainly a lot, especially for a small firm of our size.
