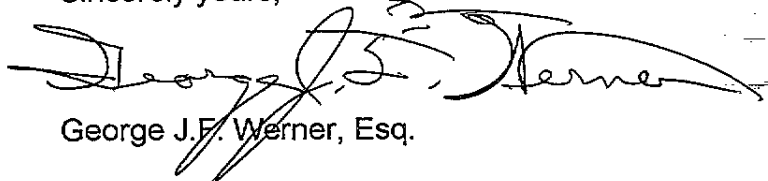

ARTICLE I: NAME

The name of the corporation shall be Paul Pulver's Pool Repair, Inc..

ARTICLE II: DURATION

The corporation shall have a perpetual existence.

ARTICLE III: PURPOSE

The purpose of this corporation is to engage in the business of pool repair.

ARTICLE IV: STOCK

The maximum number of shares which this corporation is authorized to have outstanding at any time is one thousand shares of common stock at one dollar par value per share.

ARTICLE V: BOARD OF DIRECTORS

The initial Board of Directors shall consist of two members. The number of directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of directors be less than one. The Board of Directors shall have all powers authorized by the laws of the State of Florida and the United States of America. - 1) Any stock that the corporation may issue or sell, whether or not exchangeable for any stock of the corporation of any class or classes, and whether or not of unissued shares authorized by the Articles of Incorporation as originally filed or by any amendment thereof or out of shares of stock of the corporation acquired by it after the issuance thereof, and whether issued for cash, labor done, personal property, or real property or leases thereof; or
- 2) Any obligation that the corporation may issue or sell which is convertible into exchangeable for any stock of the corporation of any class or

classes, or to which is attached or pertinent any warrant or warrants or other instrument or instruments conferring on the holder the right to subscribed or purchase from the corporation any shares of its stock of any class or classes.

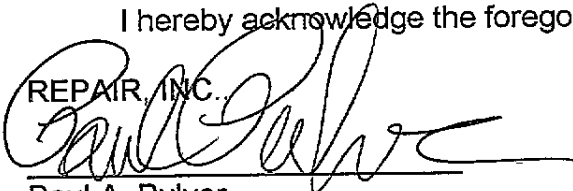

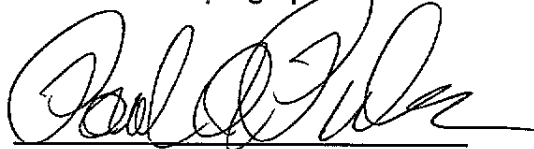
