ARTICLES OF INCORPORATION

Of

FENG SHUI NURSERY, CORP.

We, the undersigned, all of whom are of legal age, do hereby associate ourselves for the purpose of becoming a corporation under the laws of the State of Florida authorizing the formation of Corporation.

ARTICLE I

NAME

The name of this Corporation shall be: FENG SHUI NURSERY, CORP.

ARTICLE II

GENERAL NATURE OF BUSINESS

The general nature of the business and the objects and purposes proposed to be transacted and carried on are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might or could do, biz: AGRICULTURAL IN GENERAL
