ARTICLES OF INCORPORATION

We, the undersigned subscribers, are organizing a corporation for profit pursuant to the Statutes of the State of Florida providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be Tri City Tree Surgeons, Inc. The principal place of business of said corporation shall be at 8725 Dusty Lane, New Port Richey, Florida 34655-1001, and the mailing address of the corporation shall be the same.

ARTICLE II

The registered office of said corporation shall be in Pasco County, Florida, which address shall be 8725 Dusty Lane, New Port Richey, Florida 34655-1001, and George M. Brown is hereby designated as the Registered Agent for service of process for said corporation at said address.

ARTICLE III

The purpose of the corporation is to engage in any activities or business permitted under the laws of the State of Florida or the United States.

ARTICLE IV

The corporation shall be authorized to issue Five Thousand and no/100 Dollars (\$5,000.00) in stock as follows:

ARTICLE V

The corporation shall begin business with a paid in capital of Five Hundred and no/100 Dollars (\$500.00), which may be in cash or the equivalent value in property.

The corporation shall have a perpetual existence unless dissolved according to law.

The number of directors of this corporation initially shall be three (3); however, this number may be changed from time to time by lawful amendment of the By-Laws provided each number shall not be more than nine (9) and less than three(3).
