

The undersigned, acting as incorporator of a corporation under the Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation for such corporation.

1. The name of the corporation is NEW WORLD PIONEERS, INC.
2. The period of its duration is perpetual.
3. The purpose of the corporation is to establish a non-profit organization, in the business of rendering humanitarian aid and the promotion of peace in African and other countries through education and endowment. To further this cause, the corporation is authorized to engage in fund-raising in any manner in which a charity may lawfully raise funds. To further this purpose, the corporation will establish and qualify as a foundation in compliance with Section 501 of the Internal Revenue Code of 1954. The power to amend these articles for this purpose is reserved to the directors.

The corporation may carry on business overseas under the name of Les Pioniers du Nouveau Monde. This is the French translation of the name. France is the primary language of Ruanda. A foundation trust is authorized under these articles.

4. Qualifications of members and the manner of their admission shall be regulated by the by-laws.
5. The address of the corporation's initial registered office is c/o Charles Perry, 1100 Cleveland Street, Suite 900, Clearwater, FL 33755. The name of the registered agent at such address is CHARLES PERRY. Charles Perry is designated as the Senior Attorney for the company, and is authorized to act on behalf of the company in furtherance of its purposes expressed herein. He shall

serve at the pleasure of the board.

6. The number of directors constituting the initial Board of Directors is three, whose names and addresses are:


7. The name and address of the incorporator is Charles Perry, 1100 Cleveland Street, #900, Clearwater, Florida 33755.

8. The corporation has a non-discriminatory policy as to members and therefore does not discriminate against applicants and members on the basis of race, color and national or ethnic origin.

10. Any defacto actions of the corporation taken on or after March 1, 2001 are confirmed and ratified as actions of the corporation.

11. Corporate existence shall begin on May 8, 2001.


ACCEPTANCE OF DESIGNATION OF REGISTERED AGENT
