

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

1. The name of the corporation is BETTER LIFE CENTER, INC.
2. The period of its duration is perpetual.
3. The purpose of the corporation is to engage in counseling, management or any businesses or activities which are permitted under the laws of the United States and the State of Florida.
4. The corporation shall have authority to issue 10,000 shares of one dollar par value common stock.
5. The address of the corporation's initial registered office is 1100 Cleveland Street, Clearwater, FL 33755. The name of the registered agent at such address is Charles Perry.
6. The principal office of the corporation is located at 715 Wood Drive, Clearwater, FL 33755.


ACCEPTANCE OF DESIGNATION OF REGISTERED AGENT
