**ARTICLES OF INCORPORATION  
OF

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I - Name**

The name of the corporation is **BEAR PROPERTY MANAGEMENT, INC.** The principal place of business of the corporation is 4100 Corporate Square, #137, Naples, Florida 34104. The mailing address of the corporation is 4100 Corporate Square, #137, Naples, Florida 34104.

**ARTICLE II - Commencement and Duration**
