The undersigned subscriber to these Articles of Incorporation, being licensed to practice law under the laws of the State of Florida, is a natural person competent to contract and hereby adopts the following Articles to form a Corporation for profit under the Florida Professional Service Corporation Act, Chapter 621, Florida Statutes, and other laws of the State of Florida.

**ARTICLE I
CORPORATE NAME**

The name of the Corporation is: East Coast Legal Associates, P.A.

**ARTICLE II
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The principal place of business and mailing address of the Corporation is:

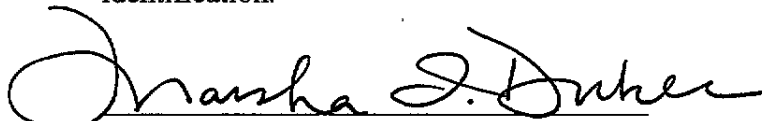

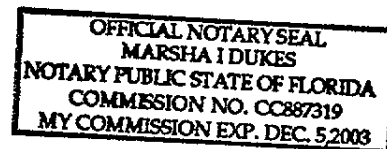
