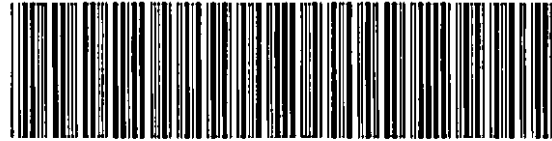

The dissolution was approved by the Shareholders. The number of votes cast in favor of the dissolution was 100 which was sufficient for approval pursuant to law.

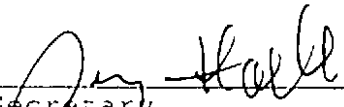
