

ARTICLE I - NAME

The name of the corporation is PARADA, INC.

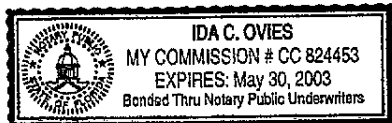
