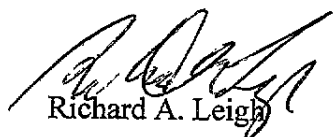

**ARTICLES OF INCORPORATION
OF**

ARTICLE I. NAME

The name of this corporation is **MODULAR DIMENSIONS
CONSTRUCTION SERVICES AND DEVELOPMENT, INC.**

ARTICLE II. PURPOSE

This corporation is organized for general corporate purposes,
and for the purpose of transacting any or all lawful business.

ARTICLE III. CAPITAL STOCK

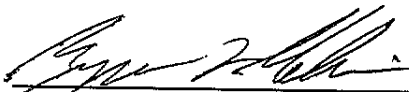

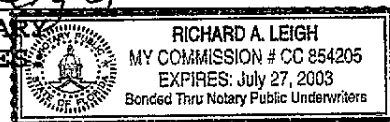
