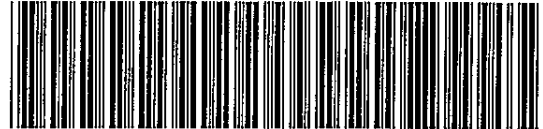

FIRST: Amendments Adopted:
