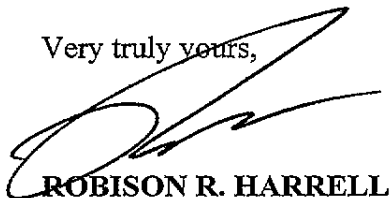

ARTICLE I

NAME

The name of this corporation is CARPET MASTERS OF THE EMERALD COAST.

ARTICLE II

DURATION

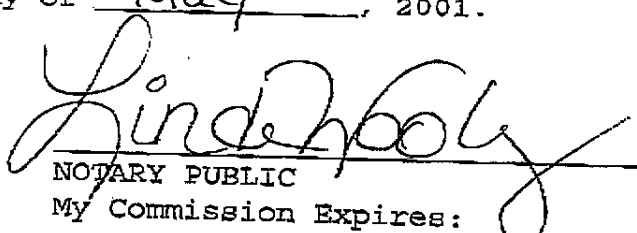

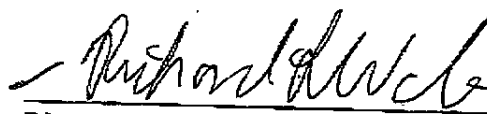
