

**ARTICLES OF INCORPORATION
OF
BAYVILLE DEVELOPMENT, INC.**

I, the undersigned natural person, acting as incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation is Bayville Development, Inc.

ARTICLE II

Principal Office and Mailing Address

The address of the principle office of the corporation is Post Office Box 31162, Palm Beach Gardens, Florida 33420-1162.

ARTICLE III

Purposes

The purposes for which the corporation is organized are to engage in any lawful activity within the purposes for which a corporation may be organized under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes.

ARTICLE IV

Capital Stock

The aggregate number of shares which the corporation shall have authority to issue is One Hundred (100) shares, consisting of one class only, designated as "Common Stock," of the par value of (\$1.00) per share.






