

ARTICLE 1: CORPORATE NAME: The name of this corporation is Oasis Pub, Inc.

ARTICLE 2: PRINCIPAL OFFICE: The street address of the initial principal office of this corporation is 3224 West Commercial Boulevard, Tamarac, Florida 33309.

ARTICLE 3: MAILING ADDRESS: The initial mailing address of this corporation is 3224 West Commercial Boulevard, Tamarac, Florida 33309.




