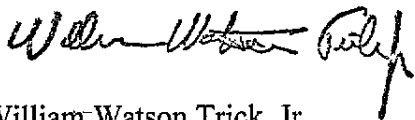

ARTICLE 1: CORPORATE NAME: The name of this corporation is A & B Medical Billing & Consulting Services, Inc.

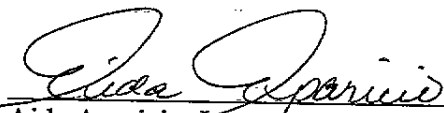

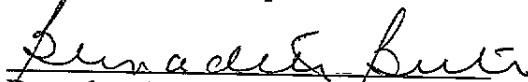
