ARTICLE I: NAME

The name of the corporation is: **Pro Clean Pressure Cleaning, Inc.**

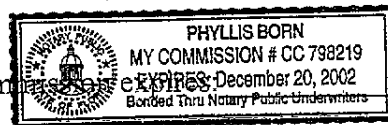




