ARTICLES OF INCORPORATION OF

The undersigned acting as Incorporator of a corporation and Step OF STATE the Florida General Corporation, Act, adopts the following Articles of Incorporation for such corporation:

- 1. Name. The name of this corporation is MCLAFFERTY & SONS INC.

 - 3. <u>Duration</u>. The period of its duration is perpetual.

8. By-Law Amendment. The power to adopt, alter, amend or

Any action of the shareholders may be taken without a meeting if consent in writing setting forth the actions so taken shall be signed by all the stockholders who would be entitled to vote upon such action at a stockholders meeting and filed with the Secretary of the corporation as part of the corporate records.
