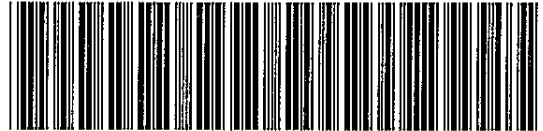

This Amendment is dated this 19th day of March, 2004.

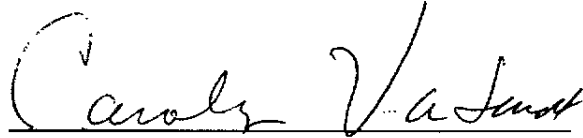
