ARTICLES OF INCORPORATION

OF

HAIR BY TRISH, INC.

The undersigned, acting as the Incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation is HAIR BY TRISH, INC.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and Florida as specifically limited by Florida Statutes Chapter 621.

Number:	The aggregate number of shares that the corporation shall have the authority to issue is 1000 shares of Common Stock.
Voting Rights:	Each of these shares will entitle the holder to 1 vote per share.
Par Value:	Each share shall have a stated par value of \$.10

The preemptive right of any holder is determined by the ratio of authorized and issued shares of Common Stock owned by the shareholder to all shares of Common Stock currently authorized and outstanding.


ARTICLE VIII

Notice must be given by any shareholder to the President or Vice-President of said corporation not less than 24 hours prior to the time set for the holding of the shareholder's meeting for the election of directors that said shareholder intends to cumulate his vote at said election.


