ARTICLES OF INCORPORATION OF



MORTGAGEASE, INC. OF JACKSONVILLE

ARTICLE 1- NAME

The name of the Corporation is MORTGAGEASE, INC. OF JACKSONVILLE

ARTICLE II-PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be 11635 Poydras Lane, Jacksonville, Florida 32218.

ARTICLE III- PURPOSE

Guarantee or secure for any other person, firm, or corporation for any purpose or transaction.

Make gifts of its property or cash, either to charitable organizations to otherwise, when deemed in the interest of the company.

Adopt such pension profit sharing, stock option, and other compensation plans for officers, employees, and directors may deem to be in the interest of the company.

The foregoing clauses shall be construed both as objects and powers, the enumeration of which shall not be held to limit or restrict in any manner the powers or

activities of this corporation which shall have the power to engage in any activity which may be necessary or profitable and generally shall have and enjoy all powers, privileges and immunities of business incorporated under the laws of the State of Florida.

ARTICLE IV-SHARES

The maximum number of shares, which this corporation is authorized to have outstanding at any one time, is 50,000 shares.

Such shares shall consist of a single class of common stock and shall have per value of \$1.00 per share.

ARTICLE V - DIRECTORS

This corporation shall have one director initially. The number of directors may either be increased or decrease from time to time by the By-Laws, but shall never be less than one.
