**ARTICLES OF INCORPORATION
FOR
AIRCRAFT CUSTOM INTERIORS, INC.**

Article I. Name. The name of the corporation shall be **AIRCRAFT CUSTOM INTERIORS, INC.**

Article II. Principal Office. The principal place of business is 3804 St. Lucie Boulevard, Fort Pierce, FL 34946.

Article III. Purpose. The purpose for which the corporation is organized is to conduct any lawful business for which corporations may be formed under Chapter 607, Florida Corporation Act.

Article IV. Shares. The aggregate number of shares which the corporation is authorized to issue is 1,200 shares. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

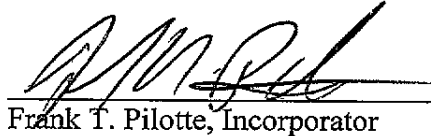
