ARTICLES OF INCORPORATION

OF

AMERICAN SUN CORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of the corporation shall be:

American Sun Corporation

ARTICLE II

DURATION

This corporation shall have perpetual existence, commencing on the date of the filing of these Articles.

ARTICLE III

INITIAL PRINCIPAL OFFICE

The initial principal office of this corporation shall be located at 4301 Silver Fox Drive, Naples, Florida 34119.

ARTICLE IV

PURPOSE

The corporation is organized for the purpose of transacting any or all lawful business.

CAPITAL STOCK
