ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is THE TOOL BOX WORLDWIDE EDUCATION, INC., and the principal address is 865 South Gulfview Blvd., Apt. 104, Clearwater Beach, FL 33767.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is 865 South Gulfview Blvd., Apt. 104, Clearwater Beach, FL 33767. The name of its registered agent at such address is Donald Scoleri.

ARTICLE III - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.

ARTICLE IV - AUTHORIZED SHARES OF STOCK

The total number of shares of stock which the corporation is authorized to issue is One Hundred Thousand (100,000) and the par value of each of such shares is Ten Cents (\$.10) amounting in the aggregate to Ten Thousand Dollars (\$10,000.00).
