ARTICLES OF INCORPORATION FOR T & S AUTO REPAIRS, INC.

The undersigned subscribers, hereby associate themselves together to form a corporation for profit under the laws of the STATE OF FLORIDA: and hereby adopt the following ARTICLES OF INCORPORATION.

NAME

The name of this Corporation shall be: T & S AUTO REPAIRS, INC. and it's business shall be carried on in BROWARD COUNTY, FLORIDA, and also within and without the STATE OF FLORIDA, and UNITED STATES OF AMERICA and FOREIGN COUNTRIES as may from time to time be deemed desirable or expedient.

ARTICLE II TERM OF EXISTENCE
