

The undersigned incorporator to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I - NAME

The name of the corporation is Advanced Entertainment Solutions, Inc.

ARTICLE II - TERM OF EXISTENCE

The date when corporate existence shall commence shall be the date of the filing of these Articles of Incorporation by the Office of the Secretary of State of the State of Florida and the corporation shall have perpetual existence thereafter.

ARTICLE III - PURPOSES

This corporation is organized for any and all lawful purposes.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue one hundred (100) shares of one dollar (\$1.00) par value common stock which shall all be of one class of Common shares.

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE X - AMENDMENT OF ARTICLES


