PRE-EMPTIVE RIGHTS

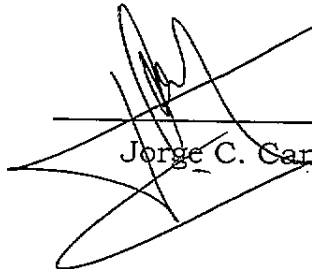

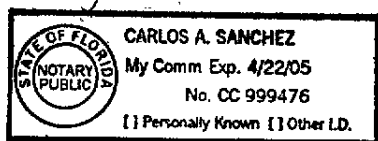

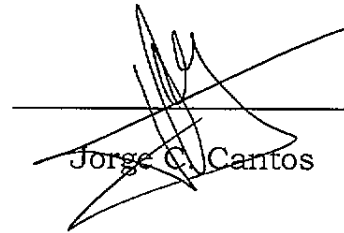
