ARTICLE I - NAME

The name of this corporation is Porterhouse Installations, Inc.(hereinafter, "Corporation")

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - COMMENCEMENT OF CORPORATE BUSINESS
