ARTICLES OF INCORPORATION

OF

I, TERRY L. ROBERTS, do hereby incorporate myself for the purpose of becoming a corporation for profit under Florida law.

ARTICLE I

The name of the corporation is: TOTAL PIPELINE
CLEANING SERVICE, INC..

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

This corporation is organized to provide residential and commercial drain cleaning and maintenance service, including but not necessarily limited to, the cleaning and unclogging of drain plumbing. The corporation may also provide other services directly related to the foregoing functions that are not prohibited by law.

ARTICLE IV

The aggregate number of shares of stock which this corporation may issue is One Hundred Thousand (100,000), all of which shall be common shares with a par value of One Dollar (\$1.00) per share. Each shareholder of any class of stock of this corporation has full preemptive rights to purchase any corporate securities carrying rights of subscription to, and/or acquisition of, any unissued or treasury stock.

ARTICLE VII


