ARTICLE III: DURATION

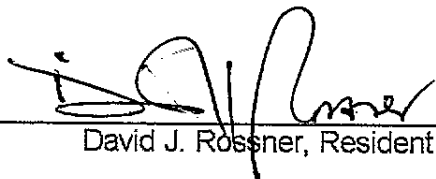
This corporation shall have perpetual existence.
