The undersigned acting as subscriber(s) of a corporation under the Florida Corporation Law, adopt the following Articles of Incorporation for such Corporation.

Article I

The name of the Corporation is **RUEDA RESTORATION, INC.**

Article II

The purpose for which the Corporation is organized is to engage in any activities or business permitted under the Law of the United States and the State of Florida.

Article III

The maximum number of shares which the corporation is authorized to issue and have outstanding at any one time is 60 shares of Common Stock, and which common stock shall be of no par value; all stock is to be issued as fully paid and exempt from assessment.

Article IV

The capital with which the corporation shall begin business is not less than \$ 300.00 (Three hundred dollars).

Article V

The period of duration of the corporation is perpetual.

Article VI

The initial post office address and principal office of the corporation in the State of Florida, shall be at 4236 W. 16 Ave. Hialeah, FL 33012. The Board of Directors may from time to time move the principal offices to another address within the States of Florida.

Article VII

Article VIII

The number of directors constituting the initial Board of Directors, consists of not less than One (1) nor more than Five (5).
