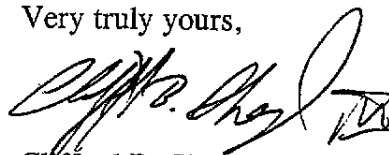

ARTICLE VII - INCORPORATOR

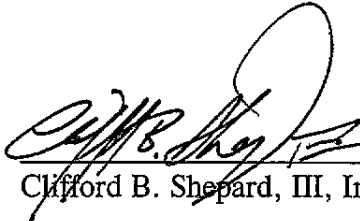
