

**ARTICLES OF INCORPORATION**

**ARTICLE I**

**NAME**

The name of this corporation is "AVT Mail, Inc."

**ARTICLE II**

##### **TERM OF EXISTENCE**

The term for which this corporation shall exist shall be perpetual, commencing on the date of execution of these Articles of Incorporation.

#### **ARTICLE V**

##### **PRINCIPAL OFFICE OF THE CORPORATION**

The principal office of the business of the corporation shall be 2301 Park Avenue, Suite 404, Orange Park, Florida 32073. The Board of directors may, from time to time, change the principal office and mailing address to any other address in Florida.



**AMENDMENTS**

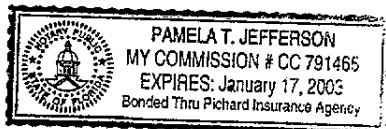




