ARTICLES OF AMENDMENT

OF

1. The name of the corporation is "**AVT MAIL, INC.**"
2. Article I of the Articles of Incorporation of **AVT MAIL, INC.**, hereby are amended in their entirety to read as follows:

NAME

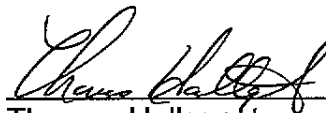
The name of the Corporation is "**ZEER TECHNOLOGY, INC.**"

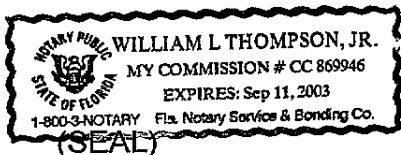
