The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Haute Dog, Inc.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on May 25, 2001 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE III - ADDRESS

The mailing address of the corporation is 25 Palm Drive, Key Largo, FL 33037.

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:


ARTICLE VIII - SHAREHOLDER PROPERTY
