To Whom It May Concern:

Please be advised that we did not receive a notice for our 2004 annual report until mid July 2004. We then sent the post card back asking for our papers to file. After receiving these back from your office, we sent signed report back to you with a check for \$18.75 on August 31, 2004. On September 15, 2004, we received the attached letter back from you, stating that our report had not been filed, and that we should have sent you \$150.00 on August 31. I am very sorry for this misunderstanding, but I read the form over and could not understand the fee was \$150.00. After speaking with "Gary" of your office, he pointed this out to me where the fee was located.

Therefore, if I understand it now, we should have sent \$150.00 plus \$8.75 for certificate of state and \$5.00 for election campaign trust for a total of \$163.75, less the \$18.75 you already have, for a new total of \$145.00.
