# ARTICLES OF INCORPORATION OF CENTURY III MEDIA, INC.



## **ARTICLE I - NAME**

The name of this corporation is CENTURY III MEDIA, INC.

# **ARTICLE II - DURATION**

This corporation shall have perpetual existence, commencing on the date of execution and acknowledgment of these Articles.
