**ARTICLES OF INCORPORATION
OF
TANGOPOLIS PRODUCTIONS CORP.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be:

**ARTICLE II
Principal Place of Business**

**ARTICLE III
Nature of Corporate Business**

The Corporation may engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way. The duration of the Corporation is perpetual.

ARTICLE IV
Capital Stock

The aggregate number of shares which the Corporation is authorized to issue is Five hundred (500) shares of common stock. 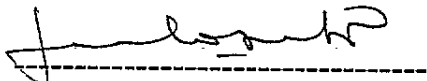
ARTICLE VIII

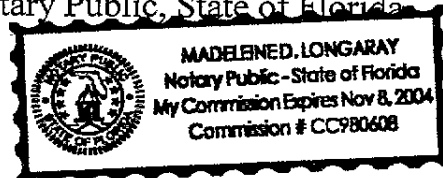
