These Articles of Incorporation, executed and filed in the Department of State, Division of Corporations in the State of Florida, by the undersigned Incorporator, for the purpose of forming a nonprofit corporation under and in accordance with the Florida Not for Profit Corporation Act.

**ARTICLE ONE**

**ARTICLE THREE**

The purpose for which the corporation is organized, and the powers which the corporation shall have, shall include the following:

3. The corporation is authorized to acquire guest speakers for the meetings, at no monetary cost to the corporation. All of the work in carrying on such activities shall be performed for the corporation without compensation.




