ARTICLE I - NAME

The name of this corporation is ELEGANT BEAUTY SUPPLIES, INC. and the principal office address is: 709 North Tamarind Avenue, West Palm Beach, FL 33401.

ARTICLE II - DURATION

This corporation shall have perpetual existence unless sooner dissolved according to the law.

ARTICLE III - PURPOSE

This corporation is organized to engage in the business of retail and wholesale distribution of cosmetics and beauty supply products and services in conformity with the the existing laws, municipal rules and regulations or such as may be hereafter enacted; and to engage in any other lawful business from time to time.

ARTICLE IV - CAPITAL STOCK

The authorized capital of the corporation is One Thousand (1000) common shares with \$1.00 par value per share.

ARTICLE X - AMENDMENT




