## ARTICLES OF INCORPORATION WOODY'S LAWN SERVICE INC.



#### Article I Name

The name of this corporation shall be WOODY'S LAWN SERVICE INC.

#### Article II Commencement & Duration

The commencement of this corporation's existence shall be at the time of the filing of these Articles of Incorporation by the Florida Department Of State. This corporation's duration shall be perpetual.

#### **Article III Purpose**

This Corporation is being organized for the purpose of engaging in the transaction of any and all business activities permitted under the laws of Florida and the United States Of America.
